Regal Investment Fund (RF1) Missed Lodgement – Appendix 3X Initial Directors' Interest Notice

Following the announcement today of the retirement of Mr. Russell Beasley as a director of Equity Trustees Limited, the Responsible Entity ("RE") of Regal Investment Fund ("RF1"), the RE advises that at the time of Mr. Beasley's appointment as a director on 1 September 2020 an Appendix 3X Initial Directors' Interest Notice was not lodged.

Further:

- 1. The RE advises that the non-lodgement of the Appendix 3X was due to an internal administrative oversight.
- 2. At the time of his appointment as a director of the RE, Mr. Beasley held one unit in RF1. At the time of his retirement as a director of the RE on 9 October 2024, Mr. Beasley held one unit of RF1. There was no change in Mr. Beasley's interests in RF1 during his tenure as a director of the RE.
- 3. The RE considers its current arrangements are adequate for ensuring timely and accurate notification and that the failure to do so on this occasion was due to an internal administrative oversight at the time the requirement to lodge arose.
 - The RE and its' directors are aware of their obligations under Listing 3.19B. Each director is made aware of this obligation pursuant to their terms of appointment which includes that a director discloses to the RE their initial interest on appointment and any ongoing disclosure of any changes.
- 4. Although the RE considers its current arrangements are adequate for ensuring timely and accurate notification, it has reviewed its procedures to ensure that it meets its' continuous disclosure obligations.
