# Regal Investment Fund (ASX: RF1)

## **JULY 2019**

The Regal Investment Fund Net Asset Value (NAV) increased by 2.8% to \$2.62 in July, with performance of over 4.9% for the Fund since listing on 17 June 2019.

The Australian equity market reclaimed its record highs in July, with general strength across the board which was underpinned by ongoing declines in global interest rates, including a 25bp reduction by the RBA to a record low cash rate of 1%.

The Market Neutral Strategy had a strong month and increased 5.8%. One of the pleasing aspects for the month was the alpha generated on the short positions. Dr Craig Collie, Regal's Healthcare Portfolio Manager, highlighted Celltrion as a conviction short at the high-profile Hearts and Minds conference in Melbourne in 2018 based on competition, excessive valuation and earnings. It is now down over 50% since Regal started shorting and fell 17% in July.

The Long Short strategy was up 3.7% in July. Positive contributors for the month included long positions in resources and technology sectors, which had strong quarterly updates and broker upgrades.

The Small Companies Strategy increased 2.0% in July. Materials was again the strongest sector in the month, with both iron ore and gold particularly strong: the \$A gold price being at record highs. This was a favourable backdrop for our positions within the sector.

The Global Alpha Strategy increased 0.9% in July. The Fund continue to build positions in this strategy whilst keeping the portfolio well hedged to market movements.

The Regal Emerging Companies Fund III completed raising capital for its initial close on 31 July 2019. The Fund will invest in emerging companies within the listed and pre-IPO markets.

#### **CURRENT EXPOSURE BY STRATEGY (NAV)**



The Manager's investment philosophy is grounded in the belief that a diversified portfolio of assets, using a range of investment strategies and backed by long-term capital, is key to achieving superior risk-adjusted returns over the long-term.

The RF1 portfolio will be constructed by the Manager using multiple investment strategies managed by Regal. The Manager may adjust the Portfolio's strategy allocations depending on prevailing market conditions or other factors it considers relevant at the time in order to achieve the RF1's Investment Objectives. The Regal investment strategies include but are not limited to five investment strategies that the Manager will use to construct the initial portfolio.
